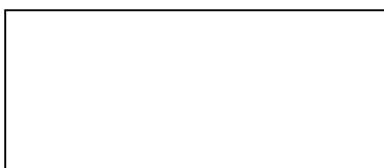

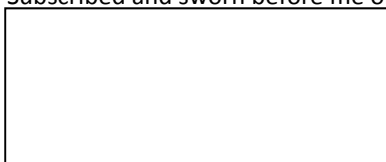

NOW THEREFORE, for a valuable consideration, which is hereby acknowledged, and the further consideration that the Surety/ **Arizona Asset Management & Recovery DBA Better Bail Bonds** would not attempt to execute the above requested bond(s) in any amount without the indemnity of this agreement, the **Defendant and/or the Indemnitor(s)** do hereby undertake, agree and bind themselves, and their successors and assigns as follows:

1. The **Defendant and/or Indemnitor(s)** will have the **Defendant** before the proper court or bail bond office as may be ordered or required by the courts or Surety/ **Arizona Asset Management & Recovery Inc DBA Better Bail Bonds**. Surety/ **Arizona Asset Management & Recovery Inc DBA Better Bail Bonds** has no liability or obligation to inform the **Defendant and/or Indemnitor(s)** of any such times or places to appear, this being the responsibility of the **Defendant and/or the Indemnitor(s)**.
2. 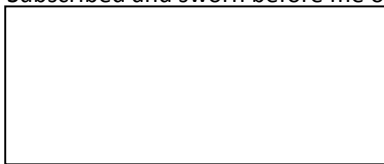

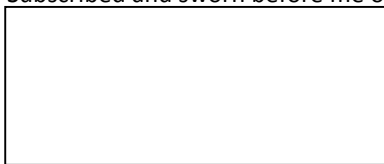

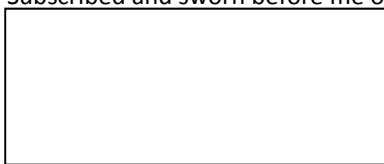
